LVMWD Brings Water and Business Together at Tap-In 2019

Las Virgenes Municipal Water District (LVMWD) hosted the inaugural Tap-In 2019 Water & Business Summit, a luncheon connecting local businesses and water professionals in a discussion about the importance of sustainability to California's economy.

Regional businesses and water industry leaders gathered at the Agoura Hills Recreation & Event Center on Thursday, November 7th to learn about current and future water supply challenges facing California residents and businesses. Mayor Pro Tem Illece Buckley Weber from Agoura Hills set the tone of the event with her welcoming remarks and spirit of collaboration.

The summit was highlighted by two speakers and a panel discussion that examined the energy-water-food nexus and how the demand for, and availability of, water directly impacts economic activity. Attendees learned ways in which businesses can implement easy and cost effective water savings and sustainability practices to save money and conserve water.

The panel, comprised of Dan Drugan from Calleguas Municipal Water District, Bridget Karl from the Calabasas Chamber of Commerce, Jill Lederer from the Greater Conejo Valley Chamber of Commerce and Dave Pedersen from Las Virgenes Municipal Water District, provided expertise and future insights into water reliability and how businesses can effectively embrace sustainability initiatives and integrate them into their business models.

Raychel Harrison, CEO and Creative Director for Calabasasbased businesses Salon Nuuvo and Nuuvo Haircare, shared her salon's successful sustainability practices, as well as how she has effectively marketed them to her clientele.

Chairwoman Gloria Gray of the Metropolitan Water District of Southern California rounded out the discussion, highlighting the importance of collaboration amongst water agencies and businesses to adequately address the water challenges of the future.



Moving forward, LVMWD is focused on facilitating the continued conversation around sustainability to support this thriving community in the present and future.

Employee Spotlight: Jonathan Vo

Meet Jonathan Vo, Water Reclamation Plant Operator at the Rancho Las Virgenes Composting Facility. Jonathan has served LVMWD customers since 1988 and has moved up the ranks from a utility apprentice with his beginnings at the Tapia Water Reclamation Facility (Tapia). In his 31 years with the District, Jonathan has alternated stints between Rancho and Tapia and most recently settled into his current position at the former.



Jonathan serves the community by ensuring customers receive the highest quality compost on the market. He understands and helps facilitate the composting process, where biosolids produced during the wastewater treatment process at Tapia are blended with high quality woodchips to make EPA certified Class A Exceptional Quality garden compost and then given away for free to the public. Coincidently, Jonathan planted a *Plumeria Frangipani* in September 2018 that managed to survive the Woolsey Fire. As pictured with Jonathan to the left, the flowers are thriving.

Jonathan not only finds great pleasure in serving this prestigious community, but also in having the opportunity to support himself and his family. As an adolescent, he arrived in America with his brother and sister from wartorn Vietnam with just a few dollars in his pocket. Through his service with LVMWD, Jonathan has been able to help his parents, sister, and brother gain citizenship in the United States.

In his spare time, Jonathan enjoys playing soccer, tennis, basketball and riding his motorcycle along the Pacific Coast Highway. He compares the feeling to that of the freedom he has gained since making a life for himself in America.


