NOTICE OF INTENT TO ADOPT

**Purpose of the Notice**

The purpose of the Notice of Intent (NOI) to Adopt a Mitigated Negative Declaration is to inform agencies and interested parties that, in accordance with California Environmental Quality Act (CEQA) Guidelines Section 15070, the Las Virgenes Municipal Water District-Triunfo Joint Powers Authority has prepared an Initial Study - Mitigated Negative Declaration (IS-MND) for the proposed Tapia Water Reclamation Facility 003 Outfall Rehabilitation Project. This NOI provides information about the project and instructions for reviewing and submitting comments on the IS-MND.

**Project Location**

The project site is located within Malibu Creek State Park along Malibu Canyon Road in Los Angeles County. The project site consists of a linear alignment, covering approximately 1.4 acres in area, that traverses Malibu Canyon Road.

Figure 1 and Figure 2, attached to this notice, show the regional location of the project site and the project alignment and proposed infrastructure at a local scale. The project site is not included on a list of hazardous materials sites compiled pursuant to Government Code Section 65962.5.

**Project Description**

The proposed project involves inspection and repair of an existing 24-inch outfall pipeline, which runs for approximately 2,250 linear feet (approximately 0.43 mile) from the Tapia Water Reclamation Facility (WRF) located at 731 Malibu Canyon Road to Malibu Creek. Starting at the Tapia WRF, the pipeline is within paved road for approximately 0.15 mile to Las Virgenes Road/Malibu Canyon Road, which is also paved, and crosses to the east side of this road (another approximate 0.03 mile). On the east side of Las Virgenes Road/Malibu Canyon Road, the pipeline is within an unpaved access road to its terminus at Malibu Creek, approximately 0.25 mile to the south. Currently, effluent from the Tapia WRF is discharged to Malibu Creek in compliance with a National Pollutant Discharge Elimination System (NPDES) permit issued and

administered by the Regional Water Quality Control Board for the Los Angeles Region (Order No. R4-2017-0125; NPDES No. CA0056014), and this would continue under post-project conditions.

The project would involve installation of five new 36-inch diameter manholes at existing bends within the pipeline alignment, which would provide access for inspection of the pipeline. One manhole would be installed along the paved entry road leading up to the Tapia WRF west of Malibu Canyon Road, and the remaining four manholes would be installed in the unpaved access road east of Malibu Canyon Road. The existing unpaved access road would be expanded to a maximum width of 20 feet. Inspection of the pipeline would not expand its capacity or alter its existing uses. Construction would occur over approximately two months.

The public review period begins on August 15, 2024 and ends on September 16, 2024. All comments should be provided in writing and received before 5:00 p.m. on September 16, 2024.
