On behalf of the Los Angeles County Medical Association (LACMA), we are writing to express our strong support for the Pure Water Project Las Virgenes-Triunfo (PWP). As physicians dedicated to promoting public health and well-being in our community, we recognize the critical importance of ensuring a safe, reliable, and sustainable water supply for our region.

The LACMA understands that the PWP will utilize advanced water treatment technologies, including micro/ultrafiltration, reverse osmosis, and ultraviolet light/advanced oxidation, to produce highly purified water that meets or exceeds all regulatory standards. This multi-step process effectively removes pathogens, pharmaceuticals, personal care products, and other contaminants, resulting in water that is purer than many traditional sources.

We appreciate that the PWP will provide up to 30% of the local water needs, creating a crucial buffer against the uncertainties of climate change and erratic weather patterns. This project aligns with California's mandate for "Conservation as a California Way of Life" and represents a proactive approach to long-term water reliability.

The LACMA recognizes several key benefits of the PWP:

1. Public Health Protection: The advanced treatment process ensures the highest quality of water, safeguarding public health.

including six months of storage in a reservoir, before distribution. This comprehensive

ensure water quality and safety.

California. We are confident in the project's success, as evidenced by the Silicon Valley

Advanced Water Purification Center from Valley Water, which has already demonstrated

that the same treatment processes to be used in the Pure Water Project Las Virgenes-

Triunfo can provide a clean, healthy, reliable, and safe water resource.

The LACMA encourages ongoing public education about the necessity and safety of water

reuse. We believe that informed community support is crucial for the success of this

important project.
