#### **SUMMARY**

As a Los Angeles-Ventura County multi-jurisdictional authority, the Las Virgenes–Triunfo Public Financing Authority (PFA) is required to adopt a Conflict of Interest Code and to file the Statement of Economic Interest Form 700 for its Board members and designated positions with the Fair Political Practices Commission (FPPC) (Title 2, Division 6, California Code of Regulations §18750).

The Joint Powers of Exercise Agreement for the Las Virgenes—Triunfo Public Financing Authority authorized the Executive Director to sign and execute, of behalf of the PFA, the Declaration of Chief Executive Officer for Multi-County Agencies and Notice of Intention to Adopt or Amend a Conflict of Interest Code with the FPPC.

On September 12, 2024, the following were submitted to the FPPC for approval: 1) Notice of Intent to Adopt or Amend a Conflict of Interest Code; 2) Draft PFA Conflict of Interest Code; and 3) Declaration of Chief Executive Officer.

Pass, approve, and adopt proposed Resolution No. 1, adopting the Conflict of Interest and Disclosure Code of the Las Virgenes–Triunfo Public Financing Authority.

**WHEREAS**, the Political Reform Act, Government Code Section 81000, *et seq.*, requires state and local government agencies to adopt and promulgate conflict of interest codes; and

**WHEREAS**, regulations have been established governing the form of Conflict of Interest and Disclosure Code to be adopted by the Las Virgenes–Triunfo Public Financing Authority ("Authority"); and

**WHEREAS**, pursuant to the Political Reform Act, Fair Political Practices Commission ("FPPC") Regulation 18730 (2.California Code of Regulations Section 18730) may be adopted as the model code for use by this Authority.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Board of the Las Virgenes—Triunfo Public Financing Authority, does hereby adopt by reference FPPC Regulation 18730 (2. California Code of Regulations Section 18730), and any amendments thereto, as the Authority's Conflict of Interest and Disclosure Code, including the attached Appendix A, setting forth the designated positions within the Authority and their disclosure obligations, and Appendix B, setting forth the disclosure categories.

**BE IT FURTHER RESOLVED,** that individuals holding designated positions shall file Statement of Economic Interests electronically with the FPPC.

**BE IT FURTHER RESOLVED,** that a certified copy of this Resolution, including the attached Conflict of Interest and Disclosure Code of Las Virgenes–Triunfo Joint Powers Authority, shall be forwarded to the FPPC.

## LAS VIRGENES-TRIUNFO PUBLIC FINANCING AUTHORITY CONFLICT OF INTEREST CODE

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. Sec. 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices designating positions and establishing disclosure categories, shall constitute the conflict of interest code of the Las Virgenes-Triunfo Public Financing Authority ("Authority").

Officials and employees holding positions listed in this code must file their statements of economic interests electronically with the **Fair Political Practices Commission**. All statements must be made available for public inspection and reproduction under Government Code Section 81008.

#### **APPENDIX "A"**

The following positions are NOT covered by the code because they must file under Government Code Section 87200 and, therefore, are listed for informational purposes only:

An individual holding one of the above-listed positions may contact the Fair Political Practices Commission for assistance or written advice regarding their filing obligations if they believe their position has been categorized incorrectly. The Fair Political Practices Commission makes the final determination whether a position is covered by Government Code Section 87200.

The Executive Director of the Authority may determine in writing that a particular consultant or new position, although a "designated position," is hired to perform a range of duties that is limited in scope and thus, is not required to comply fully with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's or new position's duties and based upon that description, a statement of the extent of disclosure requirements.

<sup>\*</sup>Consultants/new positions shall be included in the list of designated positions and shall disclose pursuant to the broadest disclosure category in the code subject to the following limitation:

The Executive Director's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code. (Government Code Section 81008.)

**Note:** The positions of Executive Director, Assistant General Manager, Deputy Treasurer, Director of Finance and Administration, Director of Engineering and External Affairs, Director of Engineering and Facilities, Director of Water Operations, Customer Service Manager, Executive Assistant/Clerk of the Board, Facilities Manager, Finance Manager, Human Resources Manager, Information Systems Manager, Principal Engineer, Public Affairs and Communications Manager, Purchasing Supervisor, Resource Conservation Manager, Water Reclamation Manager, and Water Systems Manager are filled by Las Virgenes Municipal Water District staff members, but act in a staff capacity for the Authority.

### APPENDIX "B" DISCLOSURE CATEGORIES

**Category 1:** Investments and business positions in business entities, and income, including receipt of loans, gifts, and travel payments, from sources that provide supplies, materials, machinery, or equipment of the type utilized by the Authority as well as all services including, but not limited to, real estate development and consulting firms.

**Category 2:** Interests in real property located within the jurisdiction or within two miles of the boundaries of the jurisdiction or within two miles of any land owned or used by the Authority.

**Category 3:** Investments and business positions in business entities, and income, including receipt of loans, gifts, and travel payments, from sources that filed a claim against the Authority during the previous two years, or have a claim pending against the Authority.
