Las Virgenes Municipal Water District is seeking quotes from firms interested in providing Annual Potable Reservoir Cleaning and Inspections:

1) The Las Virgenes Municipal Water District is located in Western Los Angeles County with headquarters at:

4232 Las Virgenes Road Calabasas, CA 91302

- 2) The Las Virgenes Municipal Water District operates numerous pump stations and facilities related to the operation of its potable water system.
- 3) Services will be provided during normal business hours. Normal business operating hours are Monday through Friday between 7:30 am- 4:00 pm at all locations.
- 4) Terms of the Agreement shall be for one (1) year with the option to renew said agreement for no more than four (4) years subject to price modifications that have been agreed upon by the District and Contractor pursuant to the provisions of these specifications.
- 5) A set inflation indicator shall be stated in the proposal. Pricing shall remain firm for the first (1) year, while renewal periods will be in increments of one-year using stated indicator and shall not exceed four renewal periods.

Quote:

It is intended that the successful firm will enter into a fixed price agreement with the District for the services requested in the **Scope of Work.**

Scope of Work

- Vendor shall inspect current condition of the internal and external components of the five potable water reservoirs along with structural integrity.
- Kimberly, Oakridge, Saddletree, Upper Twin Lakes and Woolsey tanks were chosen to be cleaned and inspected this calendar year and 4 to 5 new tanks will be chosen for each of the next four (4) years of this contract.



- Vendor must be able to clean the five potable tanks of up to 3" of sediment using an underwater suction vacuum while causing minimal turbidity.
- Diver must wear a vulcanized rubber dry suit that is in proper working condition.
- All equipment and devices placed into the reservoir must be sanitized with at least 200 PPM chlorine solution which allows the reservoir to remain online during the cleaning and inspection process.
- A high-definition video of the cleaning and inspection process must be provided to LVMWD upon completion of each reservoir.
- A detailed written report with photos must be provided upon completion of each reservoir.
